EDITORIAL

Our last newsletter spoke of decisions pending about NCRC and the research function of the Australian Catholic Bishops Conference. As recorded in the Minutes of the Meeting of the Central Commission of 9 April, n.4, and 28 November, 1988, n.6, five motions have now been carried, namely:

- 1. "That Conference appoint a Research Officer who will be accountable to the Conference through the Conference Secretary who will allocate tasks which will have priority over other work undertaken by the Officer; that this Officer will keep the bishops aware of opportunities, needs and problems that already exist or are likely to arise in the Church and society; that this Officer's function in most cases will not be to do Research but to see that it is done; that in commissioning research this Officer will make use of existing research groups and where necessary ensure that other appropriate task forces are convened".
- 2. That the National Catholic Research Council, through the Research Officer appointed by the Australian Catholic Bishops Conference, advises the Conference on research matters.
- 3. That the National Catholic Research Council be the responsibility of the Bishops Central Commission.
- 4. That the Research Officer maintain frequent contact with each member of the National Catholic Research Council which will meet two or three times annually and be serviced by the Research Officer and staff.
- 5. That the Secretary of the Australian Catholic Bishops Conference be chairman of the National Catholic Research Council which will consist of five or six distinguished experts from different research disciplines appointed by the Australian Catholic Bishops Conference on the recommendation of the Central Commission.

The operations of NCRC will consequently remain in abeyance until the next Central Commission meeting in March, 1989.

These decisions of the Central Commission clearly give strong support to a research function for the Bishops Conference. This connection of a newly formulated NCRC to the Central Commission further emphasizes the importance of research, as well as its potential usefulness for pastoral concerns. The membership of the new NCRC by lay experts enhances contacts with the research community and maintains an essential dialogue with the broader Australian culture. On all these issues the NCRC has already presented submissions that are in agreement in principle. The previous NCRC will have no necessary connections with the newly constituted Committee; however, the traditions, networks and connections already established will be carried forward into new arrangements. He look forward to this new organisation of research for the Bishops Conference.
